

## Campus Health Center Immunization Requirement Information Fall 2025 - Spring 2026

### **Required Student Immunizations**

- MMR (Measles, Mumps, Rubella) 2 doses after 1st birthday
- Tdap (Tetanus, Diphtheria) 1 booster in the last 10 years
- Varicella (Chickenpox) 2 doses OR verification of chickenpox diagnosis
- Meningitis 2 types of immunizations are required
  - MenACWY/MCV4 (Menactra/Menveo/MenQuadfi) Students typically receive 2 doses - 1st at age 10-12 and 2nd after age 16. <u>At minimum, we</u> require 1 dose after age 16.
  - MenB (Bexsero/Trumenba) 2 doses
- Hepatitis B 3 doses
- Polio 4 doses
- We DO NOT require flu or Covid-19 immunizations

#### **Submitting Immunization Records**

- Incoming students will submit records/file for exemptions <u>AFTER</u> they attend SOAR (new-student orientation)
- Records are collected online via MedProctor. Students will receive an email (to their Trine email address) from MedProctor during the summer. The email will contain a link that will take you to their website.
- Once students upload their record, MedProctor will review it within 2-4 business days. They will notify students if they are missing any immunizations.
- If a student receives a new immunization after submitting their record, they can upload their updated record and MedProctor will re-review it
- <u>Submitting records to MedProctor is FREE for students.</u> If you are prompted to pay or experience issues with uploading records, use the customer service "Chat Now" feature at the bottom right-hand corner of the screen.
- If a student would like to request an exemption, they can also use the "Chat Now" feature. Tell them you would like to file for an exemption and they will assist you with that process.
- MedProctor is a secure service and all student immunization records will be treated as confidential medical documentation

New students must submit their records or file for exemptions by the end of Fall 2025. We will offer immunization clinics in the Fall for students still needing immunizations.
